Purpose	Designed to provide spiritual support and positive guidance to clients seeking to turn their fortune, resolve immediate life difficulties, or achieve personal harmony through a simplified traditional Siamese cultural ritual. Ideal for individuals facing targeted challenges, such as career instability due to adversaries.
Cultural Background	This product originates from the Siamese cultural traditions of the Issan region in Northeast Thailand, conducted by independent Ruesi Masters following Thai Buddhist and folk customs. As a single-layer offering, it focuses on foundational energy activation for quicker, targeted spiritual upliftment.

2. Product Content and Process


6.2. Cancellation Policy
